What is this?

A sequential list of the web-based links referenced in the footnotes to *Global Migration: What's Happening, Why, and a Just Response.*

By sequential, we mean that the links are organized by page number and referenced by corresponding footnote number.

By web-based, we mean those resources that are available, and accordingly cited in *Global Migration*, with a web address.

How is this organized?

First by module, then by chapter, then by page, then by individual footnote.

Why was this done?

To make the resources easily accessible.

How is this different from the visual content displayed on the FLC Module Learning pages?

It tracks *Global Migration* by page. In contrast, on the FLC Module Learning pages, these same resources – and some others - are organized by topics.
